DDK 22.7.69. Rules for the regulation of emenditure arising from grant of Awards to Home Guards and Civil Defence Organisations by Director General Civil Defence and Commandants General Home Guards/Directors of Civil Defence of States/Union Territories.

1. TITLE

- (a) These Rules may be called Rules for the regulation of expenditure arising from grant of Awards to members of Home Guards Organisation and Civil Defence Corps enrolled/appointed under the Acts relating to these organisations.
- (b) They extend to the whole of India.

2. DEFINITIONS

In the Rules unless the context otherwise requires:-

- (a) Home Guards Organisation means the Organisation raised under the Home Guards Act of State Government/ Union Territory Administration and a Home Guard means a person enrolled under the Act.
- (b) Civil Defence Corps means the Organisation raised under the Civil Defence Act-1968 of the Union Government and a member of the Civil Defence Corps means an individual appointed under the Act.
- (c) Competent authority means the Director General Civil Defence, Ministry of Home Affairs appointed by the Central Government and the Commandant General Home Guards/Director of Civil Defence appointed by the State Government/Union Territory Administration.
- (d) Commandant General Home Guards includes Additional Commandant General Home Guards (where such posts exist).

3. OBJECT

The object of the Award is recognition of conspicuously good work or work of out standing nature in saving life, protection of property, assistance in maintenance of law and order and devotion to duty, individually or collectively, by the Home Guards and Civil Defence personnel. Awards may also be granted for other purposes which further the aims and objectives of the Home Guards and Civil Defence Organisations.

4. MONET ARY LIMIT'S FOR AWARDS

(a) Subject to the budget provision made for the purpose of granting such Awards, the competent authority may in any one case or on any one occasion grant Awards up to the except of monetary limits mentioned at sub para (c) below.

- (b) The amount of Award in any one case or on any one occasion shall not exceed the monetary limits prescribed for the competent authorities, who may, however, grant Awards at a reduced scale at their discretion.
 - (c) (i) Director General Civil Defence ... Rs.1,000.00
 - (ii) Commandant General Home Guards/ Director of Civil Defence ... Rs. 250.00
- (d) The Awards may be in cash or in kind.

5. SHARING OF EXPENDITURE

The expenditure incurred on the Awards by the Commandant's General Home Guards/Directors of Civil Defence subject to the provisions of Rules 3 and 4 above, will be shared between the Centre and the States in the same ratio as the expenditure on these organisations is borne by them viz. 50% except in the case of Assam, 5 northern districts of West Bengal and the Union Territories where the entire expenditure is borne by the Centre.

6. PRINCIPLES GOVERNING GRANT OF AWARDS

Awards may be granted to all members of the Home Guards Organisation and Civil Defence Corps including the paid staffs and to others connected with the two Organisations for:-

(a) doing conspicuously good work requiring special courage, skill or initiative in saving life from floods, fires, earthquakes, AIR RAIDs, protecting property, detecting and preventing crime, administration of law, maintenance of peace and the like.

doing work of an outstanding nature requiring prompt and intelligent observance of and obedience to orders so as to be of material, assistance in a life saving operation; in administration of law and maintenace of peace.

- (c) in exceptional cases for devotion to duty, fidelity, diligence, praiseworthy attention to the public or any other purpose which in the opinion of the competent authority is calculated to promote the reputation and efficiency of the Home Guard's Organisation and Civil Defence Corps.
- (d) for other purposes which further the aims and objectives of the two Organisations.

7. LIMITATIONS

(a) No grant of Award of a recurring nature involving any future commitments shall be made.

- (b) Awards shall not be sanctioned on requests.
- (c) "G neral good work" shall not be a ground for the grant of an Award.

3. O-ORDIN TING AUTHORITY

Director General Civil Defence or an officer specified by him shall be responsible to watch and coordinate the payments senctioned by the competent authorities so that they do not exceed the limits given at Rule 4 above.

9. CITATION

For each Award a citation should be written and a copy thereof forwarded to the Home Ministry, Orders sanctioning Awards should indicate reasons for which they are granted. The clause or clauses of Rule 6 above under which an Award is granted should also be mentioned in the order sanctioning the Award. The citation may be read at parades at the discretion of the Commandant General Home Guards/Director Civil Defence.

10. MAINT WAN CE OF ACCOUNTS

- (a) The competent authority shall cause a register of sanctions to be maintained in the form annexed to these Rules, in which shall be serially entered all the disbursements sanctioned by it.
- (b) Payments shall be made in cash by drawing the amounts in simple receipted bill form (T.R.42), or if the awardee so requests in writing, by Money Order, after deducting the Money Order Commission. The details of the payments to be made to the individuals are to be indicated in the bill itself or by attaching a statement thereto along with supporting documents when necessary.
- (c) Such of the recipients as receive payments in cash shall sign in the register of sanctions in token of their having received the amount of the Cash Awards. In respect of those to whom the payment is made by Money Order, receipt of Money Order coupons containing admovibedgement of the payee may be watched and note kept against the relevant item in the register of sanctions.
- (d) The competent authority shall periodically inspect the register of sanctions and exercise such other checks as he may think necessary for the proper account of payments.

11. AUDIT OF STICTIONS

Sanctions for Awards and expenditure against them shall be subject to Audit by the Accountant General, Central Revenues/Accounts General States and Union Territories. Vouchers in support of the Award/Sanction shall be made available for the purpose of audit.

Subject: - Grant of awards to Home Guards and Civil Defence personnels

Sir,

I am directed to refer to this Ministry's letter of even number dated the 19th October, 1968 and to say that it has been decided:-

- i) to also declare Deputy Director General Home Guards and Deputy Director General Civil Defence, Ministry of Home Affairs, as competent authorities for the grant of awards. The amount of awards granted by them shall be Rs.250.00 Peach in any one case on any one occasion; and,
- ii) the expenditure incurred on the awards by the Director General Civil Defence; and the Deputy Director General Home Guards and Civil Defence. Ministry of Home Affairs, will be met out of the budget of the Ministry of Home Affairs and will not be shareable and poolable with the States.
- 2. In order to ensure that awards made in cash or kind are handked handed over to the recipients quickly, State Union Territory Governments may consider the desireability of also authorising District Commandants, Home Guards and Controllers of Civil Defence at the district headquarters (and these are normally District Magistrates functioning in their Ex-Officio capacity) to make such awards and they may prescribe suitable lower monatary limits below Rs. 250.00 for this purpose.
- 3. It is requested that the following amendments may be made in the 'Rules for the Regulation etc.' forwarded under this Ministry's letter No.1/8/67-DGCD(HG) dated the 19th October, 1968:
 - In para 2(c) after Director General Civil Defence add the words "Deputy Director General Home Guards and Deputy Director General Civil Defence."
