  - (i) Bachelor degree in Fire Engineering from recognized university.
  - (ii) Twelve years experience in Fire Service in Government or local bodies or Public Sector undertaking, out of which five years' regular service in pay band 3 with grade pay of Rs. 6600. (Note1: Qualifications are relaxable at the discretion of the Union Public Service Commission for reasons to be recorded in writing, in the case of candidates otherwise well qualified. Note2:- The qualification(s) regarding experience is / are relaxable at the discretion of the Union Public Commission for reasons to be recorded in writing, in the case of candidates belonging to the Scheduled Castes or Scheduled Tribes if at any stage of selection the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite



experience are not likely to be available to fill up the vacancies reserved for them.)

Note1:- Departmental officer namely, Deputy Fire Adviser with ten year' regular service in that grade shall also be considered along with outside candidates and if selected for appointment to the post, shall be treated as having been filled by promotion.

**Note2:-** The Period of deputation [including short term contract (ISTC)] including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt of applications.

Note3:- For the purpose of appointment on deputation/ absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (The date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/ Pay Scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre- revised scale of pay into one grade with a common Grade Pay/ Pay Scale, and where this benefit will extend only for the post(s) for which that Grade Pay / Pay Scale is the normal replacement grade without any upgradation.
