## Enhancement of ex-gratia grant for funeral expenses for the Members of CD Corps-reg

Sir,

Ministry of Home Affairs, Government of India vide letter no VI-31011/1/98-DGCD (HG) dated 10.04.2003 had provisioned an ex-gratia of INR 1,000/- to the families of deceased Civil Defence Corps, who die while on duty for funeral expenses. The expenditure incurred by the State Govt on ex-gratia grant for funeral expenses is also one of the authorized components for sharing between the Central Government and the State Government to the limit prescribed by the Central Government.

- Now, Ministry of Home Affairs vide their letter no I-45011/67/2023-Ad(CD)-94-97 dated 14.02.2025 (Copy enclosed) has conveyed the approval to enhance the ex-gratia grant to the families of deceased Civil Defence Corps for funeral expenses from Rs 1,000/- to Rs 10,000/-.
- State Government / Union Territory Administrations are strongly advised to implement the revised rates by issuing parallel sanction in consultation with their Finance Departments. The revised rate shall be applicable from 14.02.2025 onwards. The expenditure involved in the payment of above-mentioned allowances at revised rates will only be poolable and shareable between the Central Government and the State Government.
