Sir,

I am directed to invite a reference to this Ministry's letter No.II-29020/41/88-DGCD (CD) dated 12th September 1988 and 24th July '89 regarding revision of duty and training allowance of Civil Defence Volunteers and to say that consequent upon enhancement of those allowances to the Home Guards, the question of enhancement of the duty and training allowance to Civil Defence Volunteers has been under consideration. The President has been pleased to sanction the following revised rate of duty and training allowance in respect of Civil Defence Volunteers:-

02. The above revised rate of various type of allowances for Civil Defence Volunteers supercedes the earlier sanction communicated under this

The expenditure involved in payment of above mentioned allowances at revised rates to the Civil Defence Volunteers will be poolable and shareable between the Central and State Governments as usual as per existing policy in respect of other items of authorised expenditure on Civil Defence as explained in par 5.0 OF Compendium of Instructions Civil Defence: Organisation, Operation & Training: 1993.

04. It is requested that the State Government /Union Territory Administrations may implement the revised rate of the above sanctioned allowances of Civil Defence Volunteers by issuing parallel sanction in consultation with their respective Finance Departments.
