I am directed to convey the sanction of the President to revise the rates and life span of various items of uniform for Home Guards as per details given below:-


2. As per rates indicated above, the revised ceiling cost of a full set of Home Guards uniform will be Rs.773.89. It is requested that while claiming reimbursement from the Government of India, on procurement of uniforms, the State Governments must adhere to the above revised ceiling/rates. The liability of the Government of India to reimburse expenditure on procurement of Home Guards uniform will be restricted to the above revised ceiling cost.

3. The life span and rates of various items of uniform for Home Guards as shown vide para-2 of this Ministry's letter No.VI-14021/6/88-DGCD(HG) dated 5.12.1991, is hereby superseded with the issue of this letter. The revised rates will be effective from 1st April, 2004.
